Next Meeting – Monday, September 11

The next Club meeting is scheduled for **Monday, September 11, 2017 at 11:30 am at Maggiano's Restaurant at Perimeter Mall on Ashford-Dunwoody Road** in the Capri, Bellagio Rooms (downstairs—first and second rooms on the right as you enter Maggiano's). Our speaker for the September meeting will be:

Ms. Tapsi Puri from Burns & McDonnell will provide a presentation entitled "EMERGENCY PREPAREDNESS RESPONSE TOOL: "PLANNING FOR THE UNPLANNED"

Machines fail. Humans err. Accidents happen. The key is to keep accidents from becoming disasters with a rapid response to stop the incident and mitigate the damage. To do that, information must be accessible, current and complete, so responders can make efficient decisions and gain control of the situation. That's exactly what the Emergency Preparedness and Response Tool (EPRT) from Burns & McDonnell provides. The EPRT eliminates the slow, manual process of data capture and integration and instead provides a single program where incident responders can access automated and enhanced coordination, and planning and collaboration of work during emergency events. With mobile data capture capabilities and remote updating, information available from the program's dashboard is current and updated in real time, making the response faster and more accurate.

Ms. Puri is a project manager in the technology consulting group at Burns & McDonnell. Her more than nine years of experience in the software industry and exposure to engineering trends help her to provide efficient and innovative geospatial and nongeospatial software solutions. Her current responsibilities include managing, analyzing, designing, developing, testing, debugging and implementing solutions to support an organization's information management systems.
