Topic: Cased Pipelines and Solutions

Speaker:

Felix Enriquez, Trenton Corporation
BS Civil and Environmental Engineering; NACE CP III

Background:

Felix began a career in the corrosion industry right after graduation for Southern Cathodic Protection (SCP). Worked as a Corrosion Consultant for SCP out of Atlanta, GA office from 2010 to 2014, designing, installing and testing CP systems and writing procedures for operators all throughout the Southeast and in the Caribbean. At the end of 2014, Felix (and then girlfriend Amy) moved to the Bay Area of Northern California to start a career with Pacific Gas and Electric Company (PG&E). Felix began working for PG&E as the casing program manager, with a budget of ~\$200 million on a 5-year comprehensive casing plan to assess and remove or mitigate all casings throughout a 18,500-mile gas transmission system, serving 16 million customers. In 2017 Felix was promoted to manage PG&E's Integrity Management program where he rewrote all the Direct Assessment Procedures and established companywide Direct Examination processes after benchmarking with operators both nationally and internationally. In 2019, Felix and his wife, Amy, moved back to Atlanta to start a family and to be near our large families. Felix now runs Trenton Corporations' Casing Fill Program and manages the Southeast for all Trenton anti-corrosion coatings and materials (Primers, Wax-Tapes, Outer wraps).
